THE CORPORATION OF THE VILLAGE OF TELKWA TAX RATES BYLAW NO. 753, 2022

A bylaw for the levying of rates for Municipal, Regional Hospital and Regional District purposes for the year 2022.

The Council of the Corporation of the Village of Telkwa, in open meeting assembled, enacts as follows:

- 1. The following rates are hereby imposed and levied for the year 2022
 - a) For all lawful general purposes of the municipality on the value of land and improvements taxable for general municipal purposes rates appearing in **Column** "A", "B", "C", "D" of the Schedule "A" attached hereto and forming a part hereof.
 - b) For hospital purposes on the value of land and improvements taxable for regional hospital purposes, rates appearing in **Column** "E" of the Schedule "A" attached hereto and forming a part hereof.
 - c) For the purposes of the Regional District of Bulkley-Nechako on the value of land and improvements taxable for the regional hospital district purposes, rates appearing in **Column** "F" of the Schedule "A" attached hereto and forming a part hereof.
 - d) For purposes of the Regional District of Bulkley-Nechako on the value of improvements only taxable for the regional hospital district purposes, rates appearing in **Column** "G" of the Schedule "A" attached hereto and forming a part hereof.
- 2. The minimum amount of taxation upon a parcel of real property shall be One Dollar (\$1.00).
- 3. This bylaw may be cited for all purposes as Village of Telkwa "Tax Rates Bylaw No. 753, 2022".
